RE : **TUITION AND OTHER SCHOOL FEES INCREASE IN THE COLLEGE OF LAW**

In conformity with LEB Memorandum Order No. 8 s. 2016, and in accordance with procedures practiced here in ATENEO DE NAGA UNIVERSITY in the past years, the Administration conducted the consultation meeting on our proposed tuition fee and other school fees increase for School Year 2023-2024 on March 27, 2023, Monday, 1:00 p.m. to 2:00 p.m. at the Function Room of Fr. Godofredo Alingal, S.J. Hall, Ateneo de Naga University, Main Campus.

Having considered all the inputs from this consultation, I wish to announce that Ateneo de Naga University will implement the following for School Year 2019-2020:

- 1) No Increase in Tuition Fee; and
- 2) A minimum of 5 % Increase in Other Fees and Energy Fee; and
- 3) Introduction of new fee: Learning Management System (LMS) Fee.

- (Note: No requests for refund will be honored after the second week of classes).


